What is Sports Premium?

Nationally, the Government provides funding each year to provide new, substantial primary school sport funding. This funding is being jointly provided by the Departments for Education, Health and Culture, Media and Sport, and will see the money going directly to headteachers to spend on improving the quality of sport and PE for all their children. The sport funding can only be spent on sport and PE provision in schools.

How much funding will our school receive?

At Oughtibridge Primary School, we received £19610 in the academic year 2024/25 to improve the quality of Physical Education, School Sport and Physical Activity (PESSPA) for all of the children at our school.

The purpose of the funding

Any use of the PE and sport premium must be in accordance with the terms outlined in this document. This means schools must use the PE and sport premium to:

- build capacity and capability within the school and ensure that improvements to the quality of PE, sport and physical activity provision made now are sustainable and will benefit pupils joining the school in future years; and
- develop or add to the PE, sport and physical activity that the school provides

The purpose of this document

Schools are required to publish details of the way in which they spent their funding over the previous year. At Oughtibridge Primary School, we have looked at a number of ways of presenting this information and have decided upon the following.

The Department for Education (DfE) have listed 5 Key Indicators that the effectiveness of funding can be measured against. For each Key Indicator, this document will break down the steps that we have taken to try and meet the expectations. The current Key Indicators are:

1. increasing all staff's confidence, knowledge and skills in teaching PE and sport
2. increasing engagement of all pupils in regular physical activity and sporting activities
3. raising the profile of PE and sport across the school, to support whole school improvement
4. offer a broader and more equal experience of a range of sports and physical activities to all pupils
5. increase participation in competitive sport

Rationale

The tables below give details as to how our Sports Premium funding has been spent in order to improve PE outcomes for the whole school over recent years.

How much has your school spent on internal school based extra-curricular opportunities?	£1853.31	<p>Investment in equipment and training for our Year 2 and Year 6 Sports Leaders has allowed for a greater number of children to take on leadership roles, or to engage with active minutes during the school day. The introduction of Year 2 sports leaders will also improve the award mark given to the school for the Sheffield KS1 Sports Mark, which will be confirmed in September 2025.</p> <p>For a number of years, the school has also contributed a section of sports premium funding to part- or full- funding of extra-curriculum club places to children who are on our disadvantaged register. This has ensured that cost is not a barrier to engagement for any child at Oughtibridge. By the end of the Spring Term, 76% of children on the disadvantaged register had accessed an extra-curricular opportunity, with others being targeted for places at clubs and events in the Summer Term.</p>
How much has your school spent on internal sports competitions?	£134.20	The profile of PESSPA at school continues to grow, with investment in our annual sports day events.



How much has your school spent on internal top-up swimming lessons, or broadening aquatic opportunities for pupils?	£480.00	Funds were spent this year to increase participation in competitive swimming events this year. Following curriculum swimming lessons in Year 4, Year 5 children are offered the opportunity to represent the school at Aquafest. In 2024/25, the school are Sheffield City Champions, and won bronze medals at the South Yorkshire Finals event.
How much has your school spent on internal active travel?	£0.00	N/A
How much has your school spent on internal equipment and resources?	£7998.09	The purchase, refurbishment and replacement of equipment is an important component of our approach to delivering a high-quality curriculum to pupils. When a new scheme of learning was introduced in 2023/24, staff were asked to contribute towards a list of equipment that was required to teach all elements of GS4PE. This equipment has then been purchased this year, to ensure the sustainability and quality of curriculum delivery.
How much has your school spent on internal membership fees?	£5020.90	Membership into our local school sports partnership (LINKS) and Sheffield School Federation for Sports ensure that we have sustained access to a range of sporting opportunities. These are a mix of internal and external opportunities, and so it should be noted that funding has only been accounted for once, in this row.
How much has your school spent on internal use of educational platforms and resources?	£373.50	The subscription to iMoves has offered children an access route to regular active blasts and brain breaks. This opportunity has allowed classes to regulate between lessons.

How much has your school spent on external activities organised by School Games organiser network?	£2030.00	<p>As a school, we are conscious of the high costs of entry and transport to sporting events.
